Vendor Contract

THIS AGREEMENT dated _____, between the Schoharie County Historical Society herein referred to as "SCHS" and _____, herein referred to as "vendor" for booth space for the SCHS Fall Festival to be held on October 3, 2026, 11:00 AM to 6:00 PM.

General Information

All participating food trucks must be fully self-sufficient. This includes providing your own generator and any necessary equipment to operate independently on-site. No external power sources will be available, so trucks must arrive prepared to run all electrical and operational needs without assistance.

Vendors who are selling anything to the public must be prepared to present their NYS Sales Tax ID. Vendor selling food or drink items must submit a copy of their Certificate of Insurance with their application. Schoharie County Historical Society is to be listed as an additional insured.

The event will be held rain or shine. However, in the case of extreme weather warnings, vendors are not obligated to attend. If you must cancel due to weather or any other reason, please contact us via email or phone.

Safety

SCHS is working hard to make this a safe and unique event that celebrates our talented local artisans. Safety is a top priority; all trucks, trailers, tents/canopies, tables, displays, and products must be stable, secure, and safe for attendees. Vendors are responsible for ensuring their setup complies with all applicable safety regulations and does not pose a hazard. Event staff reserve the right to require adjustments or removal of any setup deemed unsafe. Aisles and walkways must remain clear at all times.

Accessibility

Unfortunately, due to the natural terrain and layout of the site, the event location is not wheelchair accessible. The grounds include uneven surfaces and areas that may be difficult to navigate for individuals with mobility limitations. We encourage vendors to take this into consideration when planning their participation and to reach out to event staff in advance with any questions or concerns.

Arrival & Departure

Vendors are asked to arrive no later than 10:30 AM, as the event opens to the public at 11:00 AM. Please ensure you allow sufficient time to fully set up. Any extra vehicles you may have must be parked in the designated vendor parking lot by 11:00 AM.

The event will run until 6:00 PM. All food trucks are expected to remain for the full duration of the event. Vendors found to have packed up and departed prior to this time may not be invited to participate in future events.

Pricing & Deadline:

The food truck participation fee is **\$30**. All applications and payments must be submitted no later than **September 12th** to be considered. Late submissions will not be accepted. Please note that space is limited. To secure your spot, we recommend submitting your signed contract along with payment as soon as possible.

Payment

Payment may be made in the form of cash, check, or credit card. Checks must be made out to the Schoharie County Historical Society or SCHS. If you choose to pay by card, please only pay with the Square link provided to you through our email fallfest@theoldstonefort.org, we are not responsible if you send money any other way as that is a scam.

If you are unable to attend and inform SCHS by September 12, we would be happy to refund your fee.
